Master, Expert, Sharpshooter, Marksman, and Unclassified.

#### **4 PERSON: TEAM UNISEX**

"A" Division Master/Expert Class  
"B" Division Sharpshooter/Marksman Class

### **ENGLISH MATCH:**

#### **INDIVIDUAL: UNISEX;**

Master, Expert, Sharpshooter, Marksman and Unclassified.

#### **4 PERSON TEAM; UNISEX:**

"A" Division: Master/Expert  
"B" Division: Sharpshooter/Marksman

***Team Score will be an aggregate of the 4 Individual event scores, combined as a Team.***

# USPFC RIFLE-SMALL BORE-2026

## **EQUIPMENT**

**Targets:** NRA International Target A 51 will be used, see NRA Rule 4.1.

## **GENERAL SPORTS RULES for Small Bore Rifle**

Where conflicts between NRA rules and USPFC rules occur (i.e. awards formula, eligibility of competitors and substitution after competition begins), always use USPFC rules. (See *General Sports Rules*.)

## **CLASSIFICATION**

Small Bore Rifle shooters with a classification from a recognized shooting sports organization (RSSO) shall shoot in their classification for their discipline. Shooters without an RSSO classification shall be classified based upon scores they shot in USPFC matches, if available.

Small Bore Rifle shooters who have no classification will shoot in the individual "*Unclassified*" classification in accordance with USPFC Federation Rules. The classification gained in the "*Unclassified*" classification will be used for the competitor's classification in the Team Event.

**NOTE:** A competitor may shoot one (1) classification higher than their current classification and must return to their assigned classification at the completion of the match. A competitor who does not participate in any matches for five (5) years may be reclassified to the next lower classification.

# USPFC RIFLE-SMALL BORE-2026

## **SMALL BORE RIFLE RULES**

**Rifles:** NRA Match Rifle or any Rifle (NRA Rule 3.1 or 3.2).

**Sights:** See NRA rule 3.7.

### **COURSE OF FIRE**

NRA Course 7.5 ( 50 Yard Course, 3-position, indoor and outdoor courses).

Sixty (60) shots in three (3) positions, five (5) shots per bull with unlimited sighters on the sighter bull, all within the allotted time limit.

#### **3-POSITION INDIVIDUAL MATCH:**

STAGE	POSITION	ROUNDS	TIME (minutes)
1	Prone	20	20
2	Standing	20	40
3	Kneeling	20	30

**TIME LIMITS:** One (1) minute per shot for prone, one minute and half (1 1/2) per shot for kneeling and two (2) minutes per shot for standing. Each competitor has an additional five (5) minutes for each position change in a stage or match. See NRA Rule 8.1 and 8.2 (c).

#### **ENGLISH MATCH:**

50 Yard/Meter: ISSF Course 7.15.0 and NRA Course 7.4 (Prone position course)

Sixty (60) shots in Prone position, five (5) shots per bull with unlimited sighters on the sighter bull, all within 20 minutes.

**TIME LIMITS:** One (1) minute per shot for prone position. Each competitor has an additional 5 minutes for each position change in the match. See NRA Rule 8.2 (c).

#### **RESULTS TO USPFC DIRECTOR**

The SCORES OF ALL INDIVIDUAL EVENT(S) COMPETITORS ARE KEPT by the USPFC for data entry into the Classification computer program used from Games to Games. The Sport Coordinator shall be responsible for the MANDATORY SUBMISSION of all Individual event(s) scores in this sport to the USPFC Director for Rifle Small Bore. This should be done immediately upon the conclusion of the sport, and in no case later than 14 days after the conclusion of the Games.

## AWARDS

A maximum of 26 sets (1<sup>st</sup> through 3<sup>rd</sup> place) of medals will be required for this event. USPFC will advise you of the number of sets needed based on total entries, plus a reasonable margin.
