Any physical or verbal assaults on officials, competitors, spectators, coordinators or ex-officios will be met **with IMMEDIATE AND SEVERE PENALTIES**, including **EXPULSION** from these and future United States Police & Fire Championships.

Each team **MUST** have at least one (1) representative present at this meeting. It is the Captain's responsibility to make sure that every player on their roster is an eligible player. It is the Captain's responsibility to ensure that all team members know the rules of play.

GENERAL RULES

A team may consist of a maximum of 20 persons (18 players and 2 goalkeepers), plus one Non-Playing Coach.

IMPORTANT: All teams and personal equipment, including uniforms and sticks, will be supplied by the individual competitor and shall comply with the safety requirements as specified in the USA Hockey Rulebook. Pucks will be provided for pre-game warm-ups.

All required safety equipment, including helmets, must be worn in accordance with the USA Hockey rules. The USPFCA strongly recommends the use of face shields.

All players on a team will wear similar jerseys with individual numbers on the back. Each team must be equipped with dark and light (home and away) jerseys for all players. Please send team roster, with jersey numbers, to Mark Graham no later than Friday, June 3rd.

No "body checking" is permitted in any division.

Higher caliber players are not allowed in Division 2. Teams playing with higher caliber players will be disqualified from the tournament. It is your responsibility to know the level of your players. NO EXCEPTIONS!

Fighting will not be tolerated and will result in expulsion from the remainder of the tournament and possible expulsion from future United States Police & Fire Championships.
